RESOLUTION IN SUPPORT OF THE
PHOENIXVILLE ATHLETIC COMPLEX

WHEREAS the concept of the Phoenixville Athletic Complex started with the acquisition of the Meadowbrook Golf Course in 2013 and a desire by the Board of Directors to utilize the property to its full potential;

WHEREAS the Phoenixville Athletic Complex has a commitment to provide and maintain high-quality athletic fields for the students and community to use or utilize;

WHEREAS the Phoenixville Athletic Complex was envisioned to maximize the usage of the Phoenixville Area School District's athletic facilities to reduce the costs of outdoor athletic facility infrastructure purchases for the taxpayers of the District by growing the revenue generated through use of the outdoor athletic facilities;

WHEREAS the Phoenixville Athletic Complex was envisioned to help maintain the District's athletic facilities through the use of committed volunteers who routinely devote a yearly average of (30) thirty to (60) sixty hours of community service weekly in maintenance and a similar amount of time in scheduling and overseeing events;

WHEREAS the Phoenixville Athletic Complex through its use of voluntary service has saved the District (using 2019-2020 projected costs) over \$94,000 per year in grounds maintenance costs and over \$79,000 per year in scheduling and oversight costs;

WHEREAS since its inception in 2017 the Phoenixville Athletic Complex has raised over \$140,000 for District-identified infrastructure purchases;



WHEREAS the Phoenixville Athletic Complex through its leadership team and willingness to oversee construction projects further saves the taxpayers of the Phoenixville Area School District an additional (20) twenty to (30) thirty percent in construction costs for each construction project it leads

NOW THEREFORE be it resolved that the Phoenixville Area School District Board of School Directors:

1. Thanks the Phoenixville Athletic Complex for its commitment to the students, taxpayers and District for maintaining high quality safe athletic fields and grounds at a reduced cost to the taxpayers of the District
2. Recognizes and thanks the Phoenixville Athletic Complex for reducing costs of District directed maintenance and infrastructure purchases of the outdoor athletic facilities
3. Encourages the Phoenixville Athletic Complex to continue to grow the rentals of the fields to maximize the funds raised for District prioritize the outdoor athletic facility infrastructure purchases
4. Requests that administration report to the Board of Directors twice a year on the progress and projects undertaken by the Phoenixville Athletic Complex
